Please submit a paper in pdf format by June 18, 2023, via the <u>conference submission system</u>. Decisions about acceptance will be communicated by July 9, 2023. The conference will be held in English. Proposals for complete sessions dedicated to specific topics are welcome.

## SEA Award for Young Economists

The Slovak Economic Association will award a prize of €500 to the best paper authored by economist(s) who are 35 or younger. In case of joint papers, all co-authors have to fulfil this condition. Only papers presented at the conference will be considered for the Award. Authors who wish to be considered for the SEA Award for Young Economists must indicate this in the submission process.

### Registration

The regular registration fee is € 50. The fee is waived for SEA members and students. Participants will have to make their own arrangements for travel and accommodation.

Non-presenting participants are also welcome.

All participants need to register via the online form before August 18, 2023.

Presenters may be asked to serve as discussants. The organizers reserve the right to restrict the number of participants due to capacity constraints.
